Res Sir,

With reference to our letter No.: BSNLEU/ M P CIRCLE / PROBLEMS / 22 Dated 17.05.2016 on the matter under subject I am constrained to inform you that no improvement in cleanliness is reported. Non-availability of basic amenities issue has also not been addressed yet. Only our Dewas and Guna District Secretaries have expressed their satisfaction on cleanliness and other facilities. Our Circle Union express gratitude towards both SSA Heads for caring for the basic needs. But simultaneously lackadaisical attitude & heedlessness of others is not commendable.

Sir, as you are aware, a special cleanliness drive is undergoing in the whole nation. I have seen many instructions from our own Circle office titled SWACHH KARYASTHAL ABHIYAN. Directives for fire safety and guidelines to prevent fire hazards have also been issued. But unfortunately SSAs are showing full disregard to the circle office instructions and also to request letters by our Union. Their laxity needs to be viewed seriously. Swachh Karyasthal Abhiyan is appreciable and this is aimed for inculcating habit of cleanliness but regular cleanliness is must. Similarly, providing basic amenities is responsibility of SSA Heads. But the situation is very pathetic, miserable and agonizing.

It is again requested to instruct suitably to all SSA Heads to make available a clean, soothing working environment with all basic amenities,
